INTRODUCTION

'Green space' is the collective term used to denote the areas large and small, rural and urban, where people may enjoy outdoor pursuits and wildlife freely exists. These are the places we go for rest and relaxation - or for excercize and challenge. Green space is where children experience nature and adults seek respite from the stresses of modern living. Whether taking in the breathtaking views from Camel's Hump or picnicking with the kids in Burlington's Oakledge Park, green space is intrinsic to our way of life, essential to maintaining our physical and mental well-being.

In economic terms, green space represents the state's ecological infrastructure. Hiking trails, lakes, rivers and mountains are central to Vermont's tourism industry. In addition, many businesses and people are attracted to Vermont because of the environmental amenities and ecological services which our conserved lands deliver. In terms of real estate, green space increases the desirability of neighborhoods as well as property values overall. As Vermont seeks to strengthen and grow its economy, developed land must be complemented with a healthy quotient of green space so that society continues to accrue the social, economic and environmental benefits of green space.

Some of the oldest green spaces in the nation are the result of the foresight and generosity of wealthy individuals who made donations and bequests of land to the public domain. More recently, landowners have partnered with land trusts and government programs to retain their property while allowing public access and ensuring sound stewardship of the land for the long term. In these situations, the landowner sell 'partial interests' or a conservation easement which applies to the property deed in perpetuity.

Three public funding sources - the Forest Legacy Program, the Vermont Housing and Conservation Board (VHCB) and the Land & Water Conservation Fund (LWCF) - have funded a significant portion of the green space that is conserved in Vermont. The following pages describe these funding sources and the projects they have funded in Vermont since 1968.

FOREST LEGACY PROGRAM

The Forest Legacy Program promotes the sound stewardship of environmentally significant forest lands which are threatened with conversion to non-forest uses. The Forest Legacy Program, initiated by Senater Patrick Leahy and approved by Congress in 1990, is unique in that the forest lands under its protection remain within the private sector.

Legacy achieves this by purchasing conservation easements from willing private landowners, who may continue to live on the property and work it within the sustainability guidelines contained in the easement aggreement. Thus the traditional character of rural communities is maintained while conservation objectives are met. The cost advantage of purchasing an easement as opposed to an entire property is also significant.

The Forest Legacy Program is a Federal-State partnership with 14 states plus Puerto Rico currently taking part. The Federal contribution for any one project is up to 75% of the total project costs.

VERMONT HOUSING & CONSERVATION TRUST FUND

The Vermont Housing and Conservation Trust Fund was established in 1987 by the Vermont Legislature. Its purpose is to foster vital communities by preserving farmland, historic buildings, and open space and by creating affordable housing.

It is administered by the Vermont Housing and Conservation Board (VHCB) which makes grants and loans to nonprofit organizations, housing co-ops, municipalities and qualifying state agencies.


Since the fund's inception, VHCB grants and loans totaling more than \$95 million have leveraged \$300 million in other public, nonprofit and private investments for projects which have provided multiple and permanent benefits to the communities concerned. In addition to creating more than 4,500 units of affordable housing, VHCB grants and loans have been instrumental in the perpetual conservation of 155,000 acres of farmland, natural areas and recreational land.

Lands are generally protected in perpetuity by the creation of a conservation easement which applies to the property deed even when it changes ownership. A third party - usually a non-profit conservation organization such as the Vermont Land Trust - holds these easements. In this way, the land remains in private ownership and may continue to be worked sustainably. For example, the Hancock Tract, a VHCB-Forest Legacy joint project in the Northeast Kingdom conserved 31,450 forested acres which continues to produce timber and pay taxes.

LAND AND WATER CONSERVATION FUND

The Land and Water Conservation Fund (LWCF) was established by Congress in 1964 to use a portion of the revenue earned from the commercial exploitation of non-renewable public resources - primarily offshore oil and gas - for re-investment in permanent public resources, namely outdoor recreation areas.

The two objectives of the program are:

- To fund federal purchases of land and water areas for conservation and recreation and development of recreational resources open to all.
- To provide matching grants to the states and through them to local governments to assist in planning, acquisition, and conservation of land and water areas and development of needed recreation facilities.

Thus the fund is divided into federal and state grants programs. The LWCF program is administered by the National Park Service with a designated "State Liaison Officer" responsible for allocating grants in each state. Under the state grants program, LWCF moneys must be matched with an equal amount of funding from non-state sources.

In Vermont the Department of Forests, Parks and Recreation has been repsonsible for administering LWCF. Outside of such responsible agencies nationwide, public awareness of the existence of the LWCF and the crucial role it has played in the nation's recreation opportunities has been extremely low. Few parks, trails, or playgrounds identify LWCF as a funding source and since so many projects are executed by a local authority the federal origin of LWCF is further obscured.


Despite its public annonimity, LWCF grants in Vermont have exceeded \$27 million since 1968 and have helped protect green space in every county (see tables on following pages).


LWCF Threatened By Congress

The act creating LWCF allows Congress to spend up to \$900 million annually on outdoor recreation projects. However, this is subject to annual appropriation by Congress, and since the mid-1980's only a fraction of the intended \$900 million has been made available to LWCF, though not from lack of receipts from oil and gas permits (see graph on following page). In Vermont the lack of Congressional appropriations for LWCF has meant a zero-funded state-grant program since 1995 and a mere trickle of Federal grants (see graph on page 7).

Environmental groups nationwide are organizing for the restoration of a fully-funded Land & Water Conservation Fund. The Clinton administration includes some strong supporters of LWCF and the National Governor's Association at its 1997 Annual Meeting urged Congress to restore adequate LWCF funding, especially for the state grants program.

LWCF At Work In Vermont

The recreation projects to which LWCF moneys have contributed since the late 1960's vary greatly. Examples of LWCF projects include state treasures such as Camel's Hump State Park and the Mount Hunger hiking trail. Many other LWCF projects are far less high-profile, but make a significant contribution to the communities concerned. The repair of a sewerage system in a town park, the creation of a school sports field or a wheelchair access at a bathhouse - hundreds of these projects have enriched Vermonters' lives at the local level. In addition, these projects have assisted municipal authorities shoulder the financial burden of meeting the ever increasing demand for recreation facilities.

In the state of Vermont alone, hundreds of community projects have been made possible with LWCF moneys. Since 1968 the state has received more than \$27 million in LWCF funds. Practically every town in every county has benefited from LWCF money usually unbeknownst to the residents. The data for the following tables was obtained from the Vermont Department of Parks and Recreation. Many of the projects have subsequently been renamed or are known locally by an alternative name. However, the tables indicate the scale and diversity of LWCF projects, their huge contribution to the state's recreation infrastructure and speak to the importance of restoring and maintaining LWCF grants in the future.
